

Website Terms and Conditions

- a. Products on our website are subject to availability. If a watch has been sold at the same time that an online order is placed, we will notify you immediately and cancel your order.
- b. All products will remain available for sale on our website and other online platforms and will not be released for dispatch or collection until we have received payment in full.
- c. We normally charge a 2,000 GBP non-refundable deposit for any watch sourced. This amount may increase up to 100% of the total agreed price of the watch for those above 5,000 GBP. In the event that you no longer wish to purchase the watch ordered, this amount will not be refundable.
- d. If a watch that you wish to purchase is in our service centre, we will advise you immediately of any delay prior to accepting your order and endeavour to deliver within a reasonable timeframe should you wish to proceed.
- e. The images on our website are photographed to show detail and colour as clearly and accurately as possible. They are not filtered or adjusted in any way. We are not responsible for any differences in hue due to device or monitor settings.
- f. We reserve the right to alter our prices at any time and without notice as a result of updated RRP, changes in availability, fluctuations in exchange rate or any other reason.
- g. Products are sold in as is condition. The condition of each listing is represented by their respective description and image(s). We endeavor to represent each listing as accurately as possible.
- h. We do not guarantee the timekeeping accuracy of any watch movement, unless stated otherwise.
- i. We do not charge VAT on our watches as we work on the margin invoice scheme. There is no VAT to be reclaimed on any of our watches.
- j. Prices are displayed and/ or referenced in Great British Pounds (Sterling). We are also able to accept payments in U.S. Dollars, Euros and Swiss Francs. For non-GBP payments, we charge an additional fee to account for currency fluctuations and transaction costs.
- k. We accept cryptocurrency payments in Bitcoin (BTC). All prices quoted in GBP are converted to BTC at the spot rate plus a nominal fee of 2% to account for price fluctuations and transaction costs. We use a third-party service provider to accept cryptocurrency payments. Payments in BTC must be made within 24 hours of issued invoice.
- l. We also accept payments in other cryptocurrencies, including, but not limited to: Ethereum (ETH), Solana (SOL), Tether (USDT), Litecoin (LTC) and Dogecoin (DOGE). All prices quoted in GBP are converted to the respective cryptocurrency at the spot rate plus a nominal fee of 2% to account for price fluctuations and transaction costs. We use a third-party service provider to accept other cryptocurrency payments. Payments in the respective cryptocurrency must be made within 30 minutes of placing an order.

- m. Our website prices exclude domestic and international delivery. We reserve the right to refuse delivery to certain countries if we assess that there are risks to safe and secure delivery.
